Promoters

Opening an account with Goparity is free, as is the process of analysing the financing operation.

After contracting the financing services, Goparity charges a processing fee on the amount of the loan, a periodic fee for managing the loan until its maturity, and depending on the geographies or complexity of the project, additional fees on those.

- 1. Service fees applicable to the account opening process (Free)
- <u>Account Opening</u>: Free
- Loan Analysis: Free
- <u>Virtual wallet top-up on the platform (transfer of funds from investors' wallet to the promoter's wallet</u>): Free of charge

2. Service fees from *Goparity* crowdlending services

The fees applicable to the services differ depending on the type of loan contracted. Goparity classifies loans granted through its platform according to the following categories:

"Standard" Loan	Advanced Loan
 <u>No collateral</u>: Loans to Promoters based in the EU/EEA to develop projects in the country where they are based; or <u>With collateral</u>: Loans to Promoters based in the EU/EEA to develop projects in the country where they are based, with associated collateral subject to the jurisdiction of that same country. 	 Loans to Promoters based outside the EU/EEA; and/or, Loans for projects to be implemented outside the EU/EEA; and/or, Loans with associated collateral provided by the promoter or a third party subject to a law other than that of the promoter's registered office; or In general, for financing operations whose characteristics require risk analysis, legal and/or tax auditing of increased complexity by Goparity.

GOPARITY

2.1. LOAN PROCESSING FEE:

Equal to or less than 7% of the financed capital, with a minimum limit of \in 450, according to the table below. This Service fee is charged at the time of transfer of the funds raised through each campaign promoted on Goparity.

2.1.1. <u>Processing Fee (Standard Loan):</u>

2.1.2. <u>Processing Fee (Advanced Loan):</u>

Advanced processing fee applicable to Standard Loans, consisting of a percentage increase on top of the Standard Fee based on the factors described below.

2.2. LOAN SERVICING FEE:

Service fee equivalent to a percentage of the outstanding principal amount (equivalent annual rate).

Service fee charged together with the periodic instalment to be paid in accordance with the payment schedule in force for the loan and is levied on the outstanding principal in the respective period.

Servicing fee applicable to Standard Loans.
